Electric co-ops create EV charging network

Jo-Carroll Energy is implementing a two-part rate increase effective in March. I know this is not welcome news, and I want to stress this is an action we do not take lightly.

Members will see an average increase of 5.5 percent. Making up that increase are:

- a 3 percent increase included in the 2021 budget and approved by the board of directors in December 2020. The increase is necessary to cover the increased costs from our suppliers and to maintain adequate financial ratios with our lenders.
- A 2.5 percent increase deferred in the Spring of 2020 due to the COVID-19 pandemic. That increase was originally approved by the board in 2019 as part of the 2020 budget, also due to increased costs.

These rate changes also apply to our natural gas members, primarily due to increased costs from our natural gas transmission pipeline suppliers. Members will see the changes reflected on their billing statements in April.

As a not-for-profit member-owned cooperative, we strive every day to deliver energy to our members safely, efficiently and responsibly. Unfortunately, we must implement these changes so that we are able to continue to provide you with the reliable,

quality service you expect.

While profit is not the goal, we must recover the costs of doing business, as well as maintain sufficient margins to reinvest in the distribution system and satisfy covenants with our lenders.

Through cost cutting measures and delaying certain budgeted items, we were able to meet our debt service covenant this past year, but delayed projects must be completed to meet safety regulations and to continue to maintain reliable services.

We also must continue to meet our financial covenants so as not to jeopardize the fiber grants that we have been awarded, which will provide additional value to many of you. In our recent survey, 76 percent indicated high-speed internet is absolutely necessary to the quality of life, up 19 percent from last year's survey results.

As we move forward, we will continue to focus on operational excellence resulting in improved efficiencies and cost reductions. We anticipate revenue growth by adding more high-speed fiber internet service members. Added fiber services will also spread fixed costs across more members,

Petitions available for 2021 director nominations

Nomination petitions for the 2021 Jo-Carroll Energy Board of Director election are now available for the four director posts that are up in 2021.

Director posts up for election in 2021 include:

- District 5 (now represented by Pat Smith of Galena)
- District 7 (now represented by Dave Senn of Mount Carroll)
- District 8 (now represented by Russell Holesinger of Fulton)
- District 10 (now represented by Bob Kuhns of Geneseo)

Running for the board of directors and voting in the elections are benefits of being a co-op member. Directors are democratically elected by the membership.

Any Jo-Carroll Energy member residing in a district that is up for election – including the incumbent director – may petition for nomination in that district. Members interested in seeking election to the board may find more information and the nomination petition on the cooperative's website at jocarroll.com/2021-elections. Anyone without internet access may call the cooperative at 800-858-5522 and request a petition be mailed to them.

Petitions must be signed by at least 25 Jo-Carroll Energy members residing in the district for which the director is to be elected.

Petitions must be filed at Jo-Carroll Energy's headquarters no earlier than

March 8 and no later than June 4. Petitions may be mailed to: Jo-Carroll Energy, PO Box 390, Elizabeth, IL 61028. Petitions may also be dropped in the secure drop box at the office. Candidates should provide a short biographical sketch and a digital photo to be used in candidate profiles to be published in the co-op newsletter, Hi-Lines.

In order to qualify to have their names placed on the ballot, all nominees must participate in an orientation process provided by the attorney for the cooperative, assuring that all nominees fully understand the expectations and responsibilities of directors. These include but are not limited to: time demands, education expectations and fiduciary duties.

Complete details on director qualifications and the nomination procedure can be found in Jo-Carroll Energy's bylaws posted on jocarroll.com/minutes-bylaws.

Election of directors is conducted by mail and online prior to the annual meeting of members, with results announced at the meeting. If only one candidate files for a district, election is by vote of acclamation at the meeting. The 2021 Annual Meeting of Members is set for Aug. 3.

Director candidate petitions must be received at the cooperative's Elizabeth headquarters by June 4 for the name to appear on the 2021 ballot.

Applications open for Sharing Success grants



Jo-Carroll Energy is seeking applications for the 2021 Sharing Success grants. JCE will award up to three Sharing Success grants totaling \$7,500 this year.

Deadline for application is March 30. In addition, matching funds for the three grants will be applied for through CoBank's Sharing Success matching grant program, bringing the total possible grants to \$15,000.

To qualify for the grants, an organization must be a certified 501(c)(3) nonprofit organization, school or governmental entity such as a police, fire or ambulance department and be located within the JCE service territory. Applications also must have a broad reach and impact for the community served.

Recipients of the 2020 Sharing Success grants were:

- Savanna Police Department for a Watchguard video camera system
- Chadwick Fire Department for a positive pressure fan and tools
- Antique Engine & Tractor Show (Geneseo) to create a learning center and exhibit about food and farms.

Earlier Sharing Success matching grants were made to: Savanna Fire Department, Galena Area Emergency Medical Service District, Thomson Chamber of Commerce, Fulton Police Department, Village of Chadwick/Chadwick Police Department, East Dubuque Fire Department, the Galena Arts & Recreation Center and Village of Thomson.

Geothermal tax credit gets two-year extension

A 26 percent federal tax credit for geothermal installations is extended for two more years.

The tax credit extension is part of the federal government's \$900 million COVID relief package that was passed by Congress in December 2020.

The extension is good news for members considering

geothermal. It keeps the tax credit at 26 percent for residential geothermal for 2021 and 2022, essentially extending the previous credit two more years. The new law extends the credits for geothermal heat pump installations through 2023.

Residential credits are 26 percent through 2022, step down to 22 percent in 2023

and expire Jan. 1, 2024.

Commercial credits remain at 10 percent through 2023.

Electric co-ops create CHARGE EV

Regional electric vehicle charging network will alleviate range anxiety, encourage EV adoption

Jo-Carroll Energy is one of 29 electric co-ops that have created a regional electric (EV) charging network across Illinois, Wisconsin, Minnesota and Iowa. Named CHARGE EV, LLC., the network includes more than 30 Level 2 and Level 3 charging stations.

"We want to ensure when EV drivers leave their co-op service area they know other EV charging stations are available throughout the upper Midwest, powered by electric co-ops," said Mike Casper, Jo-Carroll Energy president and CEO.

The group of co-ops is planning for future growth in EVs and want to alleviate "range anxiety," which is the concern some people have about traveling in an EV without a place to charge their vehicle.

"Our goal is to provide EV owners peace of mind driving from Iowa to northern Wisconsin or from Minnesota to Illinois, knowing there are co-op powered chargers along

their route," said Jeff Springer, manager of innovation and efficient electrification at Dairyland Power Cooperative. "That will give people confidence to consider an EV and encourage growth in the EV market."

The CHARGE EV infrastructure is just the start as the group plans for additional investments in the EV market including member education on installing home chargers and encouraging members to test drive EVs.

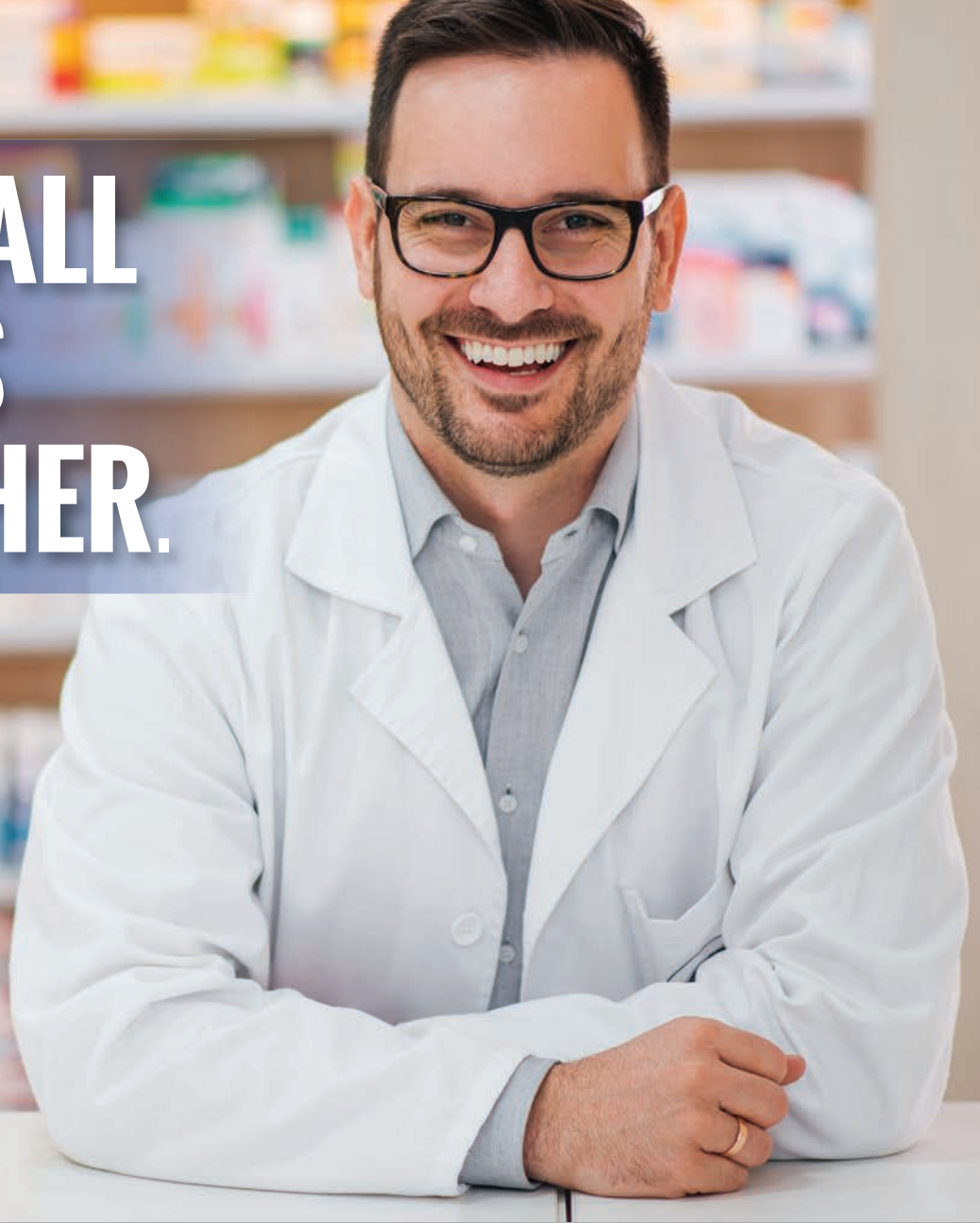
"We are proving this can be done in the upper Midwest where EV adoption has been slow, but we believe the real value will be in having other utilities join under the CHARGE EV brand," Casper said. "We hope in the near future there is a national co-op EV brand and charging network."
