To say JCE Co-op has evolved over the years is an understatement.

When I first became a member of Jo-Carroll Energy, now JCE Co-op, we served about 5,000 members. Back then, we delivered electricity and read our own meters. Today, we serve more than 30,000 members through three divisions: electric, natural gas, and high-speed fiber internet. Our fiber division continues to grow, and we expect that expansion to continue in the future. We've also upgraded to advanced meters, giving us better accuracy, faster service, and more timely information.

Each year, JCE Co-op's Annual Meeting brings members, neighbors and owners of this cooperative together. This year's theme, Evolution, fits the moment we are in.

JCE Co-op was built by people who understood that rural communities could accomplish more together than alone. The Annual Meeting is a clear reminder of the cooperative model. Members are more than customers. You elect directors, hear business updates and can ask questions about the work done on your behalf.

At this year's Annual Meeting, Board Chair Dave Senn and I will share where JCE Co-op has been, where we are today and how we are preparing for the years ahead. We will honor the hard work that built this cooperative while focusing on reliability, service, growth and operational efficiency.

2025 ANNUAL MEETING MINUTES

The Annual Meeting of the Members of JCE Co-op was held at East Dubuque High School in East Dubuque, Illinois, on Wednesday, May 28, 2025, pursuant to duly given notice.

Chairman of the Board, David Senn, called the meeting to order at 6:00 P.M. He welcomed attendees to the JCE Co-op Annual Meeting and thanked the Board of Directors and the entire JCE Co-op staff. Chairman Senn also announced that a question-and-answer session would be held at the end of the meeting.

Chairman Senn noted that this was the 86th Annual Meeting of the members and confirmed that a quorum was present.

Approval of Agenda

The Chairman called for approval of the Annual Meeting Agenda. A motion was made, seconded, and carried unanimously to approve the agenda as printed.

Welcome

Director Jerry Meyer welcomed the members and guests and thanked them for attending.

Invocation and Pledge of Allegiance

Father Ejay of St. Mary Church provided the invocation, followed by the Pledge of Allegiance led by the Chairman.

Welcome and Introductions

The Chairman introduced the Board of Directors in attendance, noting the district each represented, and identified the officers of the Cooperative. He also introduced Mike Casper, President & CEO; Terry Kurt, General Counsel; and recognized former JCE Co-op board members present at the meeting.

President and CEO's Remarks

Mike Casper, President and CEO, welcomed several special guests and recognized former and current employees, MAC members, as well as the East Dubuque School and its staff.

Approval of 2024 Annual Meeting Minutes

The Chairman stated that the minutes of the 2024 Annual Meeting were included with the official meeting notice. A motion was made, seconded, and carried unanimously to approve the minutes as printed in the annual meeting booklet.

Election of Directors

General Counsel, Terry Kurt, explained that in accordance with the bylaws, elections were held for Directors in Districts 1 and 2, and 4, and there were three Directors elected by acclamation in Districts 1, 2, and 4.

- By acclamation, Jerry Meyer of East Dubuque was elected to a three-year term representing District 1; Joe Mattingley of Scales Mound was elected to a three-year term representing District 2; and Dan Tindell of Galena was elected to a three-year term representing District 4.

Amendments to the Bylaws

General Counsel Kurt outlined amendments made this year to the Bylaws of the Cooperative, specifically:

- Article II, Section 6: Member Classes

Chairman's Report

Chairman Senn reflected on JCE Co-op's 86-year legacy of serving its members and the





strong foundation built by local people dedicated to the region for generations. He emphasized that the Cooperative's deep understanding of its communities—their needs, resources, and challenges—guides its commitment to providing reliable service while adapting to meet the evolving needs of rural America. He highlighted the expansion of high-speed fiber as a prime example of the Cooperative's continued investment in the future.

Annual Report from the President and CEO

In his Annual Report, President and CEO Mike Casper reflected on JCE Co-op's strong agricultural roots and its ongoing commitment to building a stronger future for the communities it serves. He emphasized the Cooperative's investment in the next generation through scholarships, fiber internet expansion, technology education, and reliable energy services, highlighting how innovation, local connections, and community-focused growth continue to strengthen the region for years to come.

Guest Speaker

Jason Herbert, Vice President of External Affairs at Dairyland Power provided an overview of how Dairyland is actively working to stabilize wholesale power rates and strengthen sustainability through investments in renewable energy, infrastructure, and energy efficiency and load management programs.

Acceptance of Reports

The Chairman called for a motion to accept the officers' written and oral reports, as well as the financial statements. A motion was made, seconded, and carried unanimously to accept the reports as presented.

Our annual meeting brought members together to connect, engage and celebrate the cooperative spirit that powers our community.



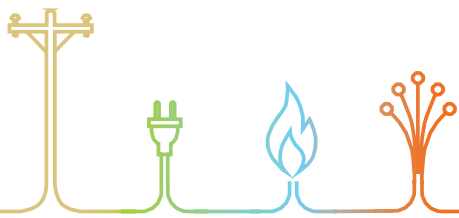
The President and CEO then answered questions from the members, alternating between questions from members present and written questions submitted prior to the start of the meeting.

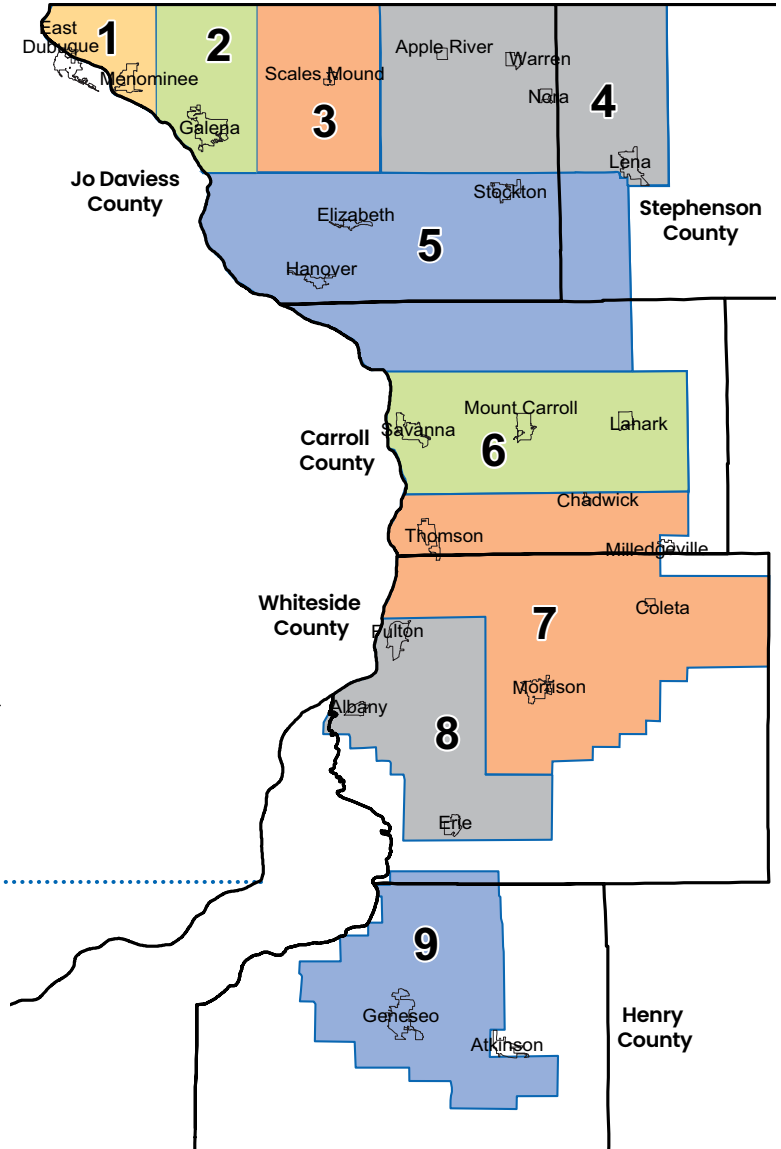

Larry Carroll

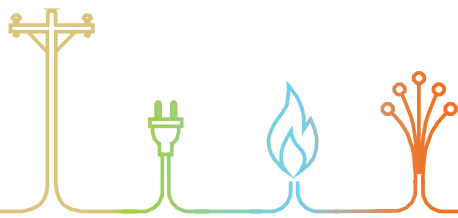
District 7

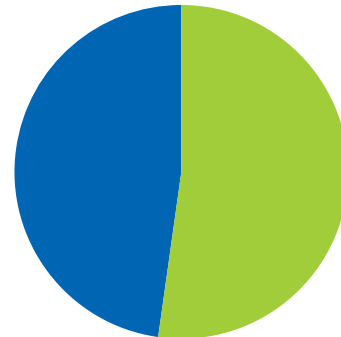

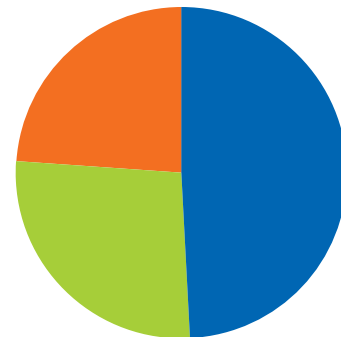

2025 Gas Usage



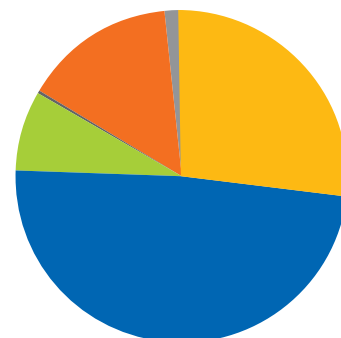
Residential-52.40% Commercial-47.60%

Changes to Bylaws in Red

ARTICLE IV DIRECTORS | Section 2 | Director Districts | Pg. 14

The Cooperative may equitably divide the general area in which Members are located or reside ("Cooperative Service Area") into ~~ten~~ **nine (9)** districts ("Director Districts"). If necessary, the Board may revise the Director District to ensure that Members are equitably represented by the Director Districts. Within thirty (30) days following any Director District revision, and at least thirty (30) days before the next Annual Member Meeting, the Cooperative shall notify, in writing, any Members affected by the

Director District revision. Director District revisions are effective on the date the Cooperative releases written notice of the Director District revision. No Director District revision may: (a) Increase an existing Directors' Director Term; or (b) Unless the affected Director consents in writing, shorten any existing Director's Director Term.

ARTICLE IV DIRECTORS | Section 4 (b) | Tenure and Qualifications | Pg. 15

(b) Qualifications. An individual shall be eligible to become or remain a director or hold a position of trust in the Cooperative if he/she meets the following qualifications:

(12) as a Director, has completed all training offered by the National Rural Electric Cooperative Association (NRECA) to have successfully completed the Board Leadership Program as defined by the NRECA (or a similar NRECA program) no later than the end of the Director's second full term of service as a Director.

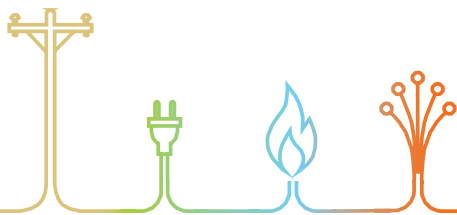
(13) as a former Director, has successfully completed the Credentialed Cooperative Director Program and the Board Leadership Program, as defined by NRECA (or similar NRECA programs).

ARTICLE VI OFFICERS | Section 9 | General Manager/President/Chief Executive Officer | Pg. 22

The Board of Directors may appoint a General Manager, who may be, but who shall not be required to be, a member of the Cooperative, and who also may be, designated President and Chief Executive Officer of the Cooperative. The General Manager/President/Chief Executive Officer shall be an ex-officio, nonvoting member of the Board of Directors and shall perform such duties as the Board of Directors may from time to time require and shall have such authority as the Board of Directors may from time-to-time vest in the General Manager.

The board of directors have the discretion to excuse the General Manager/ Chief Executive Officer from attending a board or other committee meeting.
