SUBJECT: Area Lighting

AVAILABILITY

To all members of the Cooperative for outdoor area lighting within the Cooperative service area. This service will only be available to members who agree to enter into an agreement with the Cooperative whereby the member guarantees a minimum of 12 months payments. However, should removal occur before 12 months have elapsed; the member will be required to pay the balance of the monthly fees. All or part of the payment requirement may be waived by the cooperative if a successor, in effect, assumes payment responsibility for the predecessor's remaining contractual obligation.

HOURS OF SERVICE

Dusk to dawn controlled by photo-sensitive devices, every night and all night.

TYPE OF SERVICE

Service is for lighting from Cooperative secondary lines and poles. The Cooperative will own, operate and maintain the lighting fixtures. Burned out lamps must be reported by the member, and the Cooperative will undertake to replace the lamp as soon as possible during regular working hours. Broken lamps or damaged fixtures, by accident or vandalism, will be repaired or replaced by the Cooperative at the member's expense.

SUBJECT: Area Lighting

SPECIAL TERMS AND CONDITIONS

When additional secondary facilities are required, the cost of labor and material for the additional installation will be charged directly to the member and must be paid in advance of construction. If existing facilities are adequate, the cooperative will furnish up to 120 ft. of overhead wire to feed the light. If underground service is required, the cooperative will provide up to 120 ft. of URD wire in the member's supplied trench and cooperative approved conduit. In addition, the member will provide the cooperative, free of charge, the necessary permits, right-of-way and excavations or paving cuts necessary for installation and operation of area lighting units.

Light shields will be made available for an additional fee.

POWER COST ADJUSTMENT

This rate schedule is subject to the wholesale power adjustment and the adjustment will be calculated on the following use:

LAMP RATING	MONTHLY USE
40-50 Watts LED	18 kWh
70-80 Watts LED	28 kWh
120 – 250 Watts LED	68 kWh
100 Watts – Sodium Vapor	45 kWh
175 Watts – Mercury Vapor	70 kWh
250 Watts	104 kWh
400 Watts	160 kWh

TERMS OF PAYMENT

The monthly area lighting charge will be included on the member's regular electric bill and will be due on the same date.

TAXES

The rates set forth are based on taxes currently applicable. Any increase in existing or new taxes on the transmission, distribution or sale of electricity allocable to sales hereunder shall be added to the bill.
