SUBJECT: Large General Gas Service

AVAILABILITY

Available to all non-residential members using more than 250,000 therms but less than 1,000,000 therms per year for all purposes except resale in all areas served by the Cooperative. Rate 44 is covered by this policy.

A review of member usage will occur each year. If the 12-month usage of the member is less than 250,000 therms, the member shall be transferred to the Small General Gas Service policy. The member shall remain on the assigned policy until the following annual review. All services are subject to the established rules and regulations of the Cooperative.

RATES PER MONTH

Distribution Costs:

Facility Charge:	\$41.00	per month
Member Service Charge:	\$ 9.00	per month
Delivery Charge:	\$ 0.3364	per therm

If the member has a gas transport service, the rates are below:

Facility Charge:	\$120.00	per month
Member Service Charge:	\$ 9.00	per month
Delivery Charge:	\$ 0.328	per therm

Purchased Energy Costs:

Energy Charge: Changes every month based on the monthly cost of purchased natural gas.

MINIMUM CHARGE

The minimum monthly bill shall be the sum of the monthly facility charge and member service charge.

OTHER CHARGES AND TAXES

This Schedule is subject to all other applicable charges and taxes including but not limited to: Energy Assistance, Renewable Energy and all applicable state and local taxes.
