SUBJECT: Seasonal Single-Phase Rate

**AVAILABILITY**

Available to all members for single-phase service that is seasonal in nature that uses less than 3,500 kWh during the period of April 1 through October 31. Seasonal accounts of higher usage will be reviewed on an individual basis. Residential and Commercial accounts are not eligible for this rate. Eligibility for this rate shall be determined at the time of the request. Implementation of this rate is at the sole discretion of the cooperative. Rate 12 is covered by this policy.

**TYPE OF SERVICE**

Single-phase, 60 Hertz, at allowable secondary voltages.

**RATE OPTIONS**

Any member receiving service under this schedule shall have their meter read during the April 1 and October 31 time period and be billed accordingly. The meter serving an account covered by this policy will not be read during the November 1 through March 31 time period. There will not be any invoices issued for this period. The first billing following the meter reading in April will include a reconnection fee in addition to the standard service charges listed below. Any account that exceeds 300 kWh for the April meter read will be placed on the standard single-phase rate policy and be billed monthly throughout the year. The member is responsible to inform the cooperative if the service qualifies to be billed under this policy.
