SUBJECT: Electric Heat Rate

AVAILABILITY

Available to all general service members for single-phase service having 75 kW or less electric demand and are subject to the established rules and regulations of the cooperative. Rates 27 and 120 are covered by this policy.

CONDITIONS OF SERVICE

1. The member shall have permanently installed residential electric heating equipment of 5,000 watts or more or a geothermal system.
2. Electric heat shall be the primary source of heating in the residence.
3. The member shall have in regular use at least two major electrical appliances other than the electric heat, major electric appliances being a range, built in range and oven, water heater and clothes dryer.
4. Fifty percent (50%) or more of the electrical service use is for residential purposes.
5. The Cooperative reserves the right to inspect the member's service to determine that all of the requirements are being met.
