SUBJECT: Separately Metered Water Heaters

**AVAILABILITY**

This rate policy is closed to new services. Applicable to members in the Interstate Power & Light power supply service area with existing single-phase service to electric water heaters that may be controlled and subject to the established rules and regulations of the Cooperative. This rate is applicable for the operation of thermostatically controlled insulated storage type electric water heaters of standard make and design when used in conjunction with other regular electric service metered from the same service connection. Service shall be provided through a separate meter serving water heating facilities only, with no connection or facilities for connection of other electric devices. This rate is not applicable for service for hot water space heating systems. Rate 59 is covered by this policy.

**CONDITIONS OF SERVICE**

Single-phase, 60 hertz, at available secondary voltages.

**MINIMUM CHARGE**

The minimum monthly charge shall be the sum of the facility and member service charges.
