## Working together to reduce costs

One of our biggest events of the year is coming up next month when we host our Annual Meeting of Members on Monday, June 5. I always look forward to this event because it is a great opportunity for me and other co-op employees to talk with you and hear what's on your mind.

I hope you'll join us for the meeting which will take place at the West Carroll High School in Savanna. More details about the meeting can be found inside this issue and in the annual report you'll soon receive.

Whether you attend in person or online, thank you for getting involved in your co-op. Your participation means so much to us and is reflected in this year's theme, Together Toward Tomorrow.

As we navigate the challenges and changes in the coming years, we can work together to meet the long-term needs of all Jo-Carroll Energy members by helping to manage wholesale power costs, especially during high-priced periods. These periods typically occur during extreme weather events such as very hot days in the summer – or very cold days in winter. With summer around the corner, if you can shift your usage (i.e., electric dryer, water heater, dishwasher) to a period outside a peak energy use event, we can all save money.

Electricity generation and transmission costs are a pass through to you. Approximately 65% of your electric bill is made up by the cost of wholesale

power. Wholesale power costs are usually most expensive when the demand for electricity is at its peak. Our generation and transmission cooperatives issue **peak alerts** to shift electricity use away from these peak demand times to times of less demand when electricity prices are lower.

Peak alerts are different from maximum generation or "max gen" events, which are called by the regional grid operator – the Midcontinent Independent System Operator (MISO) – for grid reliability reasons. These can be called at any time and with minimal advance notice. If we ask members to conserve electricity during a max gen event, shortage of electricity is critical and a reduction of use is necessary to help MISO avoid implementing additional steps in an emergency plan. These events can evolve rapidly and – in the most extreme scenarios – potentially result in controlled outages – or rolling blackouts – if the grid is at risk of collapsing (the production of electricity cannot keep up with electricity demand).

As we become more connected with you whether through social media, email, or text messaging we will have the opportunity to share

# Resume of Minutes

February 28, 2023

The regular board meeting of Jo-Carroll Energy, Inc. (NFP) was held on Tuesday, February 28, 2023.

**Approval of Agenda** – A motion was made, seconded, and carried unanimously approve the meeting agenda.

**Consent Agenda** – A motion was made, seconded, and carried unanimously to approve the consent agenda.

**Presentation One** – Paula Keck, Graphic Design and Marketing Coordinator, and Peggy Francomb, Director of Marketing & Communications presented the Annual Meeting Report Cover with the theme of “Together Toward Tomorrow”.

**Safety Moment** – A Safety Moment was provided by Director Jerry Meyer on the importance of knowing how to perform CPR. Jerry provided scenarios and discussed the use of Automated External Defibrillator’s (AED’s), and its ease of use.

**Presentation Two** – Ken Sivertsen, Director of Member Services, provided information and statistics on member bill payment methods, including use of Jo-Carroll Energy Offices.

### Governance Topics and Board Policy Review

**Governance Talk Video** – A Governance Talk Video on “Effective Member Advisory Groups” was presented.

### Board Policy Review

I. A motion was made by the Policy Committee to approve Board Policy 108.1/Communication and Support to the Board, which was seconded and carried unanimously.

II. A motion was made by the Policy Committee to table Board Policy 108.2/ Position Description/JCE Board Chair for further review.

III. A motion was made by the Governance Committee to approve Board Policy 108.3/President and CEO Succession Planning, which was seconded and carried unanimously.

IV. A motion was made by the Governance Committee to approve Board Policy 109/Signing of Documents, which was seconded and carried unanimously.

V. A motion was made by the Governance Committee to approve

Board Policy 109.1/Delegation of Authority, which was seconded and carried unanimously.

VI. A motion was made by the Governance Committee to approve proposed revisions to the bylaws related to District representation, which was seconded and carried unanimously. The proposed bylaw revisions will be presented to the membership during the June 5th annual meeting.

### CEO/Financial Operating Report

**CEO Report** – President and CEO Mike Casper noted that the 2023 budget factored in the past two years of higher-than-normal inflation, which considers the backlog of supplies with backlogs of up to 3 years. In addition, Casper commented on the Member Advisory Council (MAC) Meeting that will be scheduled in March and topics of discussion for the meeting.

**Financial Operating Report** – Chuck Woods, Chief Financial Officer provided a summary of the financial operating report for January. Revenue year-to-date (YTD) is approximately \$6.8 million. Total operations and maintenance expenses are approximately \$5 million, which is approximately \$614,000 under budget of \$5.6 million. Margins are approximately \$753,000 vs. a budgeted amount of approximately \$323,400 and amounts to \$430,000 over budget. By general consent, the board moved to file the financial operating report with the auditor.

### Operations and Regulatory/Legislative Update

**Operations Update** – Senior V.P. and Chief Operating Officer, Kyle Buros provided an update on the recent ice storm that affected the JCE service territory. Kyle noted that our cooperative was very well prepared for the storm and the crews did an amazing job, especially considering the number of outages scattered throughout our electric service territory. In addition, Buros reported on the continuous planning and work that is being done to prepare for added electrification and distributed energy resources.

information with you in real time of these events. And, as you become more connected with your home using the internet of things (IoT), you will have the opportunity to control usage of devices and shift or reduce usage.

For example, if you are not at home and have a wifi enabled thermostat and receive a notification from us, you could use your smartphone to increase the temperature in your home during a summer event. As we continue to grow our fiber network and the IoT expands to more appliances that consume electricity, there will be limitless opportunities that will allow you to control or shift your usage and help you and our other members save on their electric bills.

# Members to elect three directors; two contested elections

Three directors on the Jo-Carroll Energy board are up for election in 2023 including Districts 3, 6, and 9, 2 are contested elections. Because there are two candidates for Districts 3 and 6 ballots will be mailed to members in that district.

year by having more businesses participate and offering higher quality manufacturing visits."

Seven high schools from both Carroll and Jo Daviess counties participated. The combination of schools sent approximately 225 students to learn from the 14 participating businesses. In addition to hearing from multiple businesses these students also heard from two area community colleges on educational

opportunities and 2 regional agencies that offer apprenticeship programs.

"Since the event I have heard from three businesses that already have possible hires from this event," said Schmit.

Jo-Carroll Energy had employees presenting careers as an electric line worker, a broadband tech, and a natural gas technician. Each employee brought their trucks and the equipment that they use in their everyday jobs. Our HR department was also present sharing interview and hiring skills with the students.

"Jo-Carroll is always one of our biggest supporters," said Schmit "Not just with this program but in the development and growth of our communities overall."

## Budget billing accounts recalculate in May

Members with budget billing for their electric and/or natural gas accounts will have the budget amounts recalculated in May.

Because the budget amount is based on an average of the previous 12 months' use and outstanding credits or debits may accrue, the May true-up recalculation may result in an increase or decrease depending on changes in your use patterns.

Be sure to check your May statement to see if your budget amount has changed. A message in blue will appear on your statement to indicate the new budget amount if the recalculation resulted in a change. If you do not see a message on your statement, your budget billing amount remained the same.

If you have more than one billing account on budget, it is possible that one or both amounts may change.

You begin paying the new budget amount in June.

## Underground residential distribution inspections

Springtime means spring cleaning and inspections. Every year around the end of March Jo-Carroll Energy starts their underground residential distribution (URD) inspections. JCE works with contractor Karcz Utility Services of Wisconsin to perform these inspections.

This year, crews will work on URD inspections out of the Scales Mound and Guilford substations. The underground distribution lines for those stations are located in The Galena Territory and surrounding rural areas of Galena, Scales Mound, Elizabeth and Apple River.

Each year, approximately 10% of the co-op's underground facilities are inspected and maintained. Performing this periodic maintenance extends the life of our valuable underground assets and reduces the need for expensive replacements.

Karcz will open and inspect the pad-mounted transformers, sectionalizing cabinets (j-boxes) and secondary pedestals. While performing their inspections, crews will replace stickers, level cabinets, make minor repairs, remove obstructions both inside and outside of the cabinet and determine if painting is needed.

If additional work or painting needs to be completed on any of these boxes or transformers Karcz will return when the weather is warmer and more favorable for painting.

Partnerships with contractors like Karcz allow JCE to provide the best possible service to members and make sure all equipment is safe and operating properly.

# Cooperative Youth Day 2023

Jo-Carroll Energy took two students from the co-op's service territory, Kyle Haas (Stockton) and Xander Vogel (Fulton), to participate. The students were accompanied by JCE employees

Sara Lechowicz, digital media and events coordinator, and Jesse Shekleton, director of broadband operations. "Youth Day is a great way for them to make connections and broaden their knowledge about other cooperatives and areas," said Sara Lechowicz.

The trip allowed students to meet public officials, state senators and representatives to learn why it is important for every citizen to get involved in government. Students also learn why supporting local cooperatives plays such an important role in the community. The
