Each year more than 2,000 representatives from electric co-ops across the nation ascend Capitol Hill in Washington, D.C., to meet with federal representatives and advocate for priorities important to rural America.

I was especially proud of Jo-Carroll Energy's team and the other Illinois electric cooperative employees who joined forces in April to discuss the priorities that directly affect you, our member-consumers.

Our focus was on three topics:

1. Expand rural broadband access. Congress must continue to fund rural broadband programs that meet the unique challenges of serving hard-to-reach areas.

Why? A reliable broadband connection is vital for rural America and creates new ways to live, learn and earn in rural America. Jo-Carroll and more than 200 electric cooperatives across the nation are working to expand rural broadband access in unserved and underserved areas of the country, in addition to integrating smart-grid technologies to their energy networks that can improve efficiencies and our carbon footprint.

2. Alleviate supply chain challenges. Congress must help address labor shortages, invest in longterm manufacturing growth and incentivize increased domestic steel production.

Resume of Minutes

March 29, 2023

The regular board meeting of Jo-Carroll Energy, Inc. (NFP) was held on Wednesday, March 29, 2023.

Safety Moment – A Safety Moment was provided by Director Tom Lundy emphasizing the importance of reading safety manuals before operating equipment.

Approval of Agenda – A motion was made, seconded, and carried unanimously approve the meeting agenda.

Consent Agenda – A motion was made, seconded, and carried unanimously to approve the consent agenda.

Presentation One – Mark Prouhet, Managing Director of FORVIS Accounting, provided a summary of audit results for 2022 and presented the board with a clean, unmodified opinion, noting that accounting policies, management's judgement, and accounting estimates were appropriate.

Presentation Two – A Safety Video on Cooperative Vehicle Safety was shown. An in-person demonstration of Jo-Carroll Energy vehicles was performed by Becky Brown, Manager of Administrative Operations, followed.

Governance Topics and Board Policy Review

Governance Talk Video – None.

Board Policy Review - None.

CEO/Financial Operating Report

CEO Report – President and CEO Mike Casper discussed proposed Senate Bill 319. He also provided a reminder of the rate increase that will be reflected on the April billing statements.

Financial Operating Report – Chuck Woods, Chief Financial Officer, provided a summary of the financial operating report for February. Revenue year-todate (YTD) is approximately \$12.3 million. Total operations and maintenance expenses are approximately \$9.6 million, which is approximately \$9.6 million, which is approximately (\$926,808) under budget of \$10.6 million. Margins are approximately \$1.2 million versus a budgeted amount of approximately (\$458,747) and amounts to \$1.65 million over budget. By general consent, the board moved to file the financial operating report with the auditor.

Operations and Regulatory/Legislative Update

Operations Update – Senior V.P. and Chief Operating Officer Kyle Buros provided an update on the recent storms that affected the service territory and the preparations that were taken in advance. In addition, Buros provided an update on the Burns Road rebuild project and shared that JCE will be conducting a town hall meeting March 29 in Scales Mound to discuss fiber buildout plans and easements.

Member Services Update – V.P. of Member Services Jennifer Meyer discussed the brand refresh survey that will be shared with the board and employees for their input.

External Affairs/Legislative Update – Terry Kurt, Outside General Counsel, had nothing to add outside of the staff report.

Human Resources – Chuck Woods, CFO, provided an update on new hires and open positions at the cooperative.

Executive Assistant – Amy Johnston, Executive Assistant, had nothing to add outside of her written staff report.

Discussion of 2024 Strategic Planning – Strategic Planning dates were discussed and finalized.

Preparing to serve you better

Providing reliable power to you is and will always be a top priority for Jo-Carroll Energy. These days, power reliability seems to be making news more than ever.

As the energy industry continues to transition and more segments of the economy are becoming electrified, such as vehicles, machinery and even lawn equipment, additional pressures are being placed on our nation's electric grid. receiving the reliable power they depend on and deserve.

Let us be the first to say we love trees and the charm they add to the communities. While trees provide shade and add beauty to our area, you may be surprised to learn that overgrown vegetation accounts for about half of all power outages.

That is why we strive to keep the co-op's power lines clear in right-of-way (ROW) areas. A ROW area is the land a co-op



With summer storm season upon us, it is a good time to talk about a few measures Jo-Carroll is taking to ensure our members continue uses to construct, maintain, replace or repair underground and overhead power lines. This ROW enables Jo-Carroll to provide clearance of trees and other obstructions that could hinder distribution power lines. The overall goal of our vegetation management strategy is to provide reliable power to our members while maintaining our area's beauty.

Modernizing vegetation management

Generally speaking, healthy trees don't fall on power lines, and clear lines don't cause problems. Proactive trimming and pruning keep lines clear to improve power reliability. However, traditional vegetation management is costly and time-consuming. It entails on-the-ground, labor-intensive efforts involving dozens of workers assessing vegetation and overseeing the quality and completion of contractor work. Although this approach has worked for decades, advances and improvements in technology have allowed us to reduce our costs and improve efficiency ebeseZ alladaiM

Planned outages improve reliability

Although it may seem counterintuitive, we also maintain power reliability through planned, controlled outages. By carefully cutting power to one part of our local area for a few hours, JCE can perform system repairs and upgrades, which ultimately improves electric service. Planned outages can also be used to balance energy demand, but only in rare circumstances. Rest assured, we will always notify you in advance of a planned outage, so make sure we have your correct contact information on file

to receive the latest emails or mailings.

Vegetation management is an essential tool in ensuring power reliability and minimizing the risk of outages. As advancements become more accessible and costs drop, we anticipate using additional technologies to ensure a consistent energy supply while managing the environment.

ROW service work is scheduled in your area

Jo-Carroll Energy's Rightof-way (ROW) clearing and trimming will start soon and continue throughout the year. Zielies Tree Service will be performing this work on behalf of JCE.

Areas included are in the Galena and Hanover areas that are served by the Pilot Knob substation.

This ROW clearing work may or may not affect your specific property. The work can include mowing, hand-cutting and side trimming, up to and including removal as needed.

ROW clearing improves system reliability. The ROW program is a multi-year, ongoing activity.

ROW clearing is done with the goal of removing problem trees and vegetation for seven or eight years until the next clearing cycle.

Furlong awarded IEC memorial scholarship

Jacob Furlong of Galena is one of 15 winners of this year's Thomas H. Moore Illinois Electric Cooperatives (IEC) Memorial Scholarship.

The \$2,000 awards are given each year to 15 children of electric co-op members, employees or directors. A 15th scholarship is reserved for a student interested in lineworker's school and will be announced at a later date.

Furlong competed for

the scholarship with 292 other students from across the state and will be recognized during the Association of Illinois Electric Cooperatives' annual meeting on Aug. 2, 2023, in Springfield.

Why? Ongoing supply chain constraints are impeding the ability of Jo-Carroll and other co-ops to access key components and materials, which creates safety, cost and reliability concerns. It also impedes growth of businesses and new housing, which are essential to our area's economic growth.

3. Modernize the federal permitting process. Congress must pass legislation to create a more streamlined permitting process.

> Why? As we build for the future (e.g., new pipelines, facilities, fiber), the process for conducting federal environmental reviews must be more efficient and streamlined to reduce costs and provide more certainty to Jo-Carroll, as well as electric coops across the nation, to maintain affordable, reliable energy services and help bridge the digital divide.

Our involvement and advocacy on behalf of our members is vital as we work together to advance the priorities of cooperatives and our communities and improve the quality of life for members.

I look forward to seeing you and responding to your questions at the Jo-Carroll Energy annual meeting on the evening of Monday, June 5. Working together toward tomorrow will benefit all of us.

What to do before using a PORTABLE GENERATOR



Prepare Install battery operated carbon

monoxide (CO) alarms throughout your home; ensure they are working properly.

Position

Place a portable generator at least 20 feet from windows and doors; do not use one in a garage or carport.



Read

Carefully review and then follow all manufacturer's instructions.

Protect

If it is wet outside, keep it dry by placing it on a tarp. Position it under a portable canopy (not a carport).





Refuel Safely Turn off your portable generator and let it cool down before refueling.

Inspect and Maintain

Inspect a portable generator before each use and make sure it is properly maintained.


