Resume of Minutes

Aug. 28, 2024

The regular board meeting of Jo-Carroll Energy, Inc. (NFP) was held on Wednesday, Aug. 28, 2024.

Safety Moment – Director Mattingley shared safety tips on recreational safety, such as the importance of a helmet while biking and wearing life jackets while boating. In addition, always let someone know your location and how you will be traveling.

Approval of Agenda – A motion was made, seconded and carried unanimously to approve the meeting agenda.

Consent Agenda – A motion was made, seconded and carried unanimously to approve the Consent Agenda items, including the July 23, 2024, Board Meeting Minutes/Summary, Discounted Estate Retirements, and the board expense summary.

Presentation - None.

Governance Topics and Board Policy Review - None.

Governance Talk Video – A Governance Talk video was shared on "The Value of Diversity in the Boardroom." When making decisions as a board, it's important to have a variety of individuals with different skill sets, backgrounds and personalities. Deliberation and critical thinking in the boardroom lead to better decision making.

Board Policy Review - None.

CEO/Financial Operating Report

CEO Report - President and CEO Mike Casper shared that as JCE Co-op continues to grow, its business units, additional working capital and an extension of our mortgage will be needed.

Financial Operating Report – Chuck Woods, Chief Financial Officer, provided a summary of the July financial operating report. Revenue year-to-date (YTD) is approximately \$40.2 million. Total operations and maintenance expenses are approximately \$31.7 million, which is (\$1,480,118) under the budget of \$33.1 million. Margins are approximately \$2.2 million. By general consent, the board moved to file the financial operating report with the auditor.

Operations and Regulatory/Legislative Update

Operations Update – There was nothing to report outside of the written report submitted.

IT Technology Report – Dan Marcure, VP and Chief Technology Officer, provided an update on cybersecurity threats, sharing the recent cyber-attack that affected users on the Crowd Strike platform. Dan also shared ways to protect yourself from online hacking and phishing scams.

Member Services Update - Jennifer Meyer, VP of Member Services, provided an update on the advanced metering infrastructure (AMI) system upgrade. The first phase will be the use of automated handheld meter readers, which will assist in increasing efficiency when natural gas meters are read. In addition, Meyer noted that she will be providing the board a fiber message map for communication purposes.

External Affairs/Legislative Update -

General Counsel Terry Kurt shared that Congressman Darrin LaHood met with JCE Co-op Staff and participated in a tour of co-op facilities.

Executive Assistant Update – Amy Johnston, Executive Assistant, informed the Annual Planning Committee that they will meet prior to the September Board Meeting at 8:30 a.m. In addition, Johnson provided conference details for the upcoming NRECA Regional 5&6 meeting.

Board Issues and Action Items

Dairyland (DPC) Power Load Forecast Resolution Approval – A motion was made by Director Tindel to approve the DPC Power Load Forecast, which was seconded by Director Hendren and carried unanimously.

CFC Certificate of Resolution and Incumbency – A motion was made, seconded and carried unanimously to approve the CFC Certificate of Resolution and Incumbency.

Select Voting Delegate/Alternate for the NRECA Region 5&6 Meeting - A motion was made, seconded and carried unanimously to select Director Tindell as the NRECA voting delegate and Pat Smith as the alternate voting delegate for the NRECA Region 5&6 Meeting.

Select Voting Delegate for RESCO Annual Meeting - A motion was made, seconded and carried unanimously to select President and CEO Mike Casper as the voting delegate for the RESCO Annual Meeting (held in conjunction with the NRECA Region 5&6 Meeting).

Federated Rural Electric Insurance Exchange for Region 5 Meeting of Subscribers – A motion was made, seconded and carried unanimously to select Al Hendren as the voting delegate for the Federated Rural Electric Exchange Meeting of Subscribers (held in conjunction with the NRECA Region 5&6 Meeting).

Into Executive Session – A motion was made, seconded and carried unanimously to go into Executive Session at 10:51 a.m.

Out of Executive Session - A motion was made, seconded and carried unanimously to come out of Executive Session at 11:18 a.m.

Action Resulting from Executive Session - None.

Reports/Updates

Association of Illinois Electric Cooperatives (AIEC) Report -Director Senn shared highlights from the AIEC Board Meeting, noting that JCE Co-op was featured in the National Rural Electric Cooperative Association (NRECA) Magazine, an article highlighting our recent broadband efforts and value testimonials by the members of JCE Co-op.

Dairyland Power Cooperative (DPC) - Director Mattingley shared that DPC's Strategic Planning session was productive; in addition, Mattingley shared that Dairyland developed a transmission capacity map of their system.

American Public Gas Association (APGA) Report – Director Carroll discussed topics affecting the Natural Gas Industry, noting that tax exemptions should be fully

maintained as a critical tool for states, local governments and nonprofits to invest in the vital infrastructure that supports local community needs.

Prairie Power Incorporated (PPI) Report - Director Kuhns shared highlights from the PPI Board Meeting and noted that a budget forum is scheduled for October.

Badger Group Annual Meeting -It was noted that President and CEO Casper, Directors Senn, Hendren, and Meyer attended the Badger Group Annual Meeting, and highlights were shared from the meeting.

Other Business - None.

Adjournment - Chairman Senn adjourned the meeting at 12:08 p.m.

Celebrating our members



IEC Memorial Scholarship Program open for applications

The electric cooperatives of Illinois will award 17 scholarships, each worth \$2,500, to outstanding students from the electric cooperative family through the Thomas H. Moore Illinois Electric Cooperatives (IEC) Memorial Scholarship Program. Here's a brief rundown of the scholarships available.

- Ten scholarships will be awarded to high school seniors whose parent(s) are Illinois electric co-op members, giving these students a bright start on their educational journey.
- The Earl W. Struck Memorial Scholarship is reserved for a student whose parent is an Illinois electric cooperative employee or director, honoring the legacy of service within our cooperative family.
- Five scholarships are dedicated to students enrolling full-time at a two-year Illinois community college, who are also children of an electric cooperative member in Illinois.

 The LaVern and Nola McEntire Memorial Lineworker's Scholarship is designed for those ready to light up the world by pursuing a career in linework and are enrolled or plan to enroll at Lincoln Land Community College's lineworker program. This scholarship supports students of co-op members, relatives of employees or directors, and those who have served or are currently serving in the armed forces or National Guard.

Electric budget billing accounts to recalculate

JCE Co-op members with budget billing on their electric accounts will have their budget amounts recalculated in November.

Because a budget bill amount is based on an average of the previous 12 months' use and outstanding credits or accrued debits, this November true-up recalculation may result in an increase or decrease, depending on changes in your use patterns.

Be sure to look at your November statement to see if your budget amount has changed. If a change results from the recalculation, a message will appear on your statement in blue indicating the new budget amount.

If you do not see a message on your statement, your budget billing amount remains the same.

If you have more than one billing account on budget, it is possible that one or both amounts may change. You begin paying the new budget amount in December.

Invoice-billed members should remember that no messages will be printed on your bill statement regarding whether or not the budget bill amount changes. If you would like to know your new budget bill amount, please call our offices between the hours of 7:30 a.m. and 4:30 p.m. Monday-Friday or email us at info@jcecoop.com.

Budget billing can help you manage your energy costs by allowing you to allocate the same amount

each month. Monthly utility bills can vary significantly throughout the year due to variations in your usage through heating and cooling seasons.

With JCE's budget billing plan you eliminate the month-to-month fluctuations caused by changing weather and use patterns. It is imperative that members on budget billing still watch their monthly use and outstanding balances to ensure a large increase does not occur during a recalculation month.

Levelized billing also available

JCE also offers a levelized billing program. Under this plan, each monthly bill is the rolling average of your electric use for the most recent 12 months, thus eliminating true-up months.

This means you will not pay the exact same amount every month, but it will be close to the same. The amount you owe some months will be more than the average; other months it will be less.

Over the year, you will have paid what you owe. Levelized billing does not reduce your bill; it helps you manage your utility payments.

he Winter Preparedness Test for interruptible heat (dual fuel) accounts is set for Wednesday, Nov. 20.

This load control test is performed in advance of the winter Full Load Control season to ensure classes will be controlled as shown in the chart.

During the test, residential interruptible heat load

6:55 p.m.	Event Start Time-Loads will begin to be interrupted.
7:00 p.m.	All Loads will be interrupted (2, 2W, 4B).
10:00 p.m.	Class 2, 2W and 4B will begin diversified restoral.
10:30 p.m.	Class 4B loads will be fully restored.
11:00 p.m.	Class 2 and 2W loads will be fully restored.
