## CEO'S REPORT *by Mike Casper*

## Fiber, what's next?

Spring is here and the frost will soon be out of the ground. With the weather's cooperation we'll be full steam ahead with fiber construction in neighborhoods where we are actively building out in 2025.

To date, we have constructed more than 2,000 miles of fiber and connected over 7,000 fiber internet members. Within the next 3 to 5 years, JCE Co-op expects to construct an additional 1,500 miles of fiber that will provide access to more than 10,000 homes, businesses and farms. We expect fiber to be available throughout our service area by 2030, with much of that completed by the end of 2026.

The number one question we hear is, "when are we going to get fiber in our area?" It's a valid question and the answer depends on several factors.

Multiple grant awards are providing us with the opportunity to bring fiber to rural areas that would otherwise be cost-prohibitive. However, each grant has specific deadlines that we must meet, which drives the timeline in these areas. If an area does not qualify for grants, we rely on your interest and sign ups to help move projects forward.

The path we take to build out fiber most efficiently from the source or the middle mile fiber where we can obtain the bandwidth needed to serve you is also an important factor. Another is where we have the most interest or concentration outside of the grant areas.

We continue to follow a six-step process in building a fiber neighborhood. The process is described at the "Building the Fiber Neighborhood" link under the Fiber tab on our website where you can also find a "What to Expect During Construction" video.

During the construction phase, there are multiple steps before you are contacted to schedule the actual fiber installation in your home and/or business, which can take several months. These include mainline fiber placement (aerial and/or underground) and a smaller dedicated drop fiber that connects to a box on your house. After that is complete, our splicing teams will fusion splice all fiber connections and conduct tests to verify that the fiber to your house is "lit" or functional.

## Meter project continues in 2025

Work is underway to update JCE Co-op's advanced metering infrastructure (AMI) which will improve safety, enhanced system reliability and data collection.

The technology automatically collects data from the meter and transfers that data over a secure network to the co-op's database. The collected data is used for utility billing, analyzing usage trends, providing members with daily usage information as well as advanced outage and gas leak notifications for your convenience and safety.

The system rollout has already started with installation of smart node upgrades to existing natural gas meters. Some homes may receive a new natural gas meter along with the smart node, depending on the age of their natural gas meter.

The co-op expects to begin installing electric meters in late April, according to Brad Edler, Director of Engineering. JCE Co-op has contracted with Utility Metering Solutions (UMS) to install residential meters, with the goal of 10,000 to be completed this year. JCE Co-op technicians will manage and support installation of more advanced three phase meters.

Testing of the software database interface to meters began in March. "We have already received what are called first article meters, that is, electric meters that we utilize for testing purposes, making sure everything works properly," Edler said. "Because we have multiple types of meters, our vendor sends us four of each model to test. Our engineers and technicians connect each meter to the system, verifying each meter has

correct performance and provides accurate data to the software database."

"Key to the testing and operation of the system is installation of base stations that gather the readings from the meters and pass the data to the software database," Edler added. Thirty-four base stations will be installed throughout the co-op's gas and electric footprint. The base station installation is expected to be completed by the end of April.

With the upgrade to the new system, the co-op will "have increased reliability in getting timely information from meters and better communication directly to the meters," Edler said. "We will be able to make upgrades to meters via remote commands, saving money eliminating truck rolls to update meter programming."

He continued stating that the new point-to-point system replaces a power line carrier (PLC) signal system that is no longer industry supported and a radio frequency (RF) mesh system which does not work well in the co-op territory's varied terrain.

The updated system is still RF but is point-to-point instead of mesh so that the base stations communicate directly with the meters. "We've done full propagation studies, working with our provider, to verify that our terrain, the number of base stations and their locations are all where they need to be," Edler said.

Meter changes are expected to begin in late April and early May. Additional information will be provided to members by email, postcard and other co-op publications as the meter changes begin.



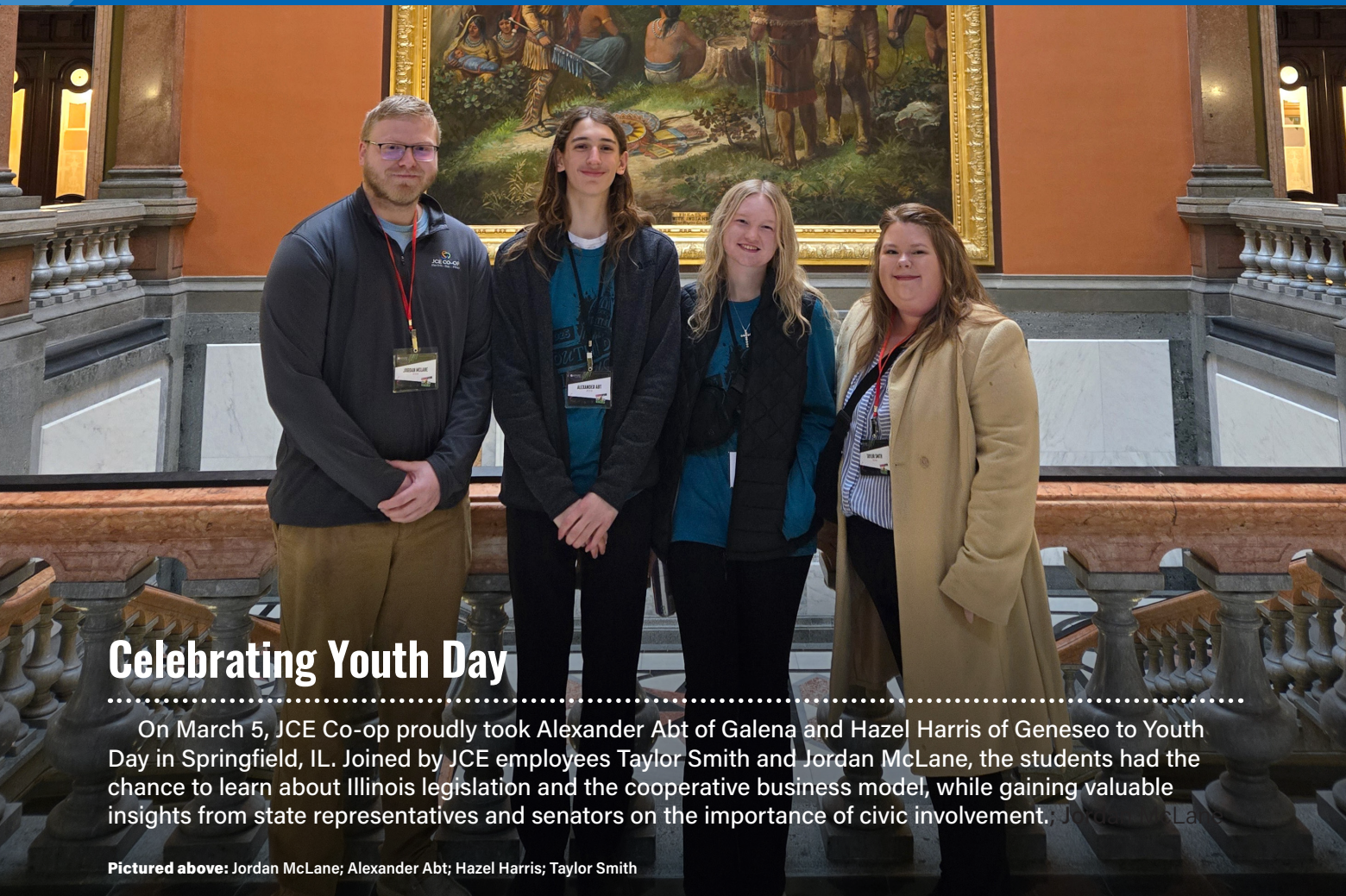
### Director's Scholarship deadline approaching!

## Resume of Minutes

**January 31, 2026**

**Board Meeting Minutes Summary**

The regular board meeting of Jo-Carroll Energy, Inc. (NFP) was held on Friday, January 31, 2025.

**Safety Moment** – Director Bob Kuhns discussed the dangers of chronic stress and practices to manage.

**Approval of Agenda** – A motion was made, seconded, and carried unanimously to approve the meeting agenda.

**Consent Agenda** – A motion was made, seconded, and carried unanimously to approve the consent agenda.

**Presentations**

CFO Chuck Woods provided a status update from the 2024 JCE Co-op Audit. Brent Ridge, Dairyland Power Cooperative President and CEO, will presented during Executive Session.

**Governance Topics and Board Policy Review** – None.

**CEO/Financial Operating Report**

**CEO Report** – President and CEO Mike Casper, shared highlights from the CEO Closeup Conference, as well as the APGA Legislative Summit. In addition, Casper shared that JCE Co-op was recently awarded a grant from Older Adults and Technology Services (OATS), and, as a result, has launched a new program with Senior Planet, a national nonprofit which harnesses technology to change the way older Americans age. JCE Co-op is offering classes and workshops about technology and other topics.

Director Al Hendren attended one of the workshops and commented positively on the program.

**Financial Operating Report** – Chuck Woods, Chief Financial Officer, provided a summary of the preliminary 2024 unaudited financial statements. Revenue is approximately \$69 million. Total operations and maintenance expenses are approximately \$56 million, which is \$942,881 over the budget of \$55.2

million, due to multiple factors. Margins are approximately \$1.9 million versus a budgeted amount of \$1.4 million and amount to \$522,628 greater than budget. By general consent, the board moved to file the financial operating report with the auditor.

**Operations and Regulatory/Legislative Update** – None.

**Board Issues and Action Items**

**Approve Proposed Revisions to Billing Policy 411/Net Metering & Avoided Costs** – A motion was made, seconded and carried unanimously to approve revisions to Billing Policy 411.

**Approve Proposed Revisions to Rate Policy 814/Infrastructure as a Service** – A motion was made, seconded and carried unanimously to approve revisions to Billing Policy 814.

**Voting Delegate for National Rural Electric Cooperative Association (NRECA) Annual Member Business Meeting** – A motion was made, seconded and carried unanimously to approve Pat Smith as the Voting Delegate for the NRECA Annual Member Business Meeting.

**Voting Delegate for the NRTC Business Meeting (held in conjunction with the NRECA Annual Meeting)** – A motion was made, seconded and carried unanimously to approve Pat Smith as the Voting Delegate for the National Rural Telecommunications Cooperative (NRTC) Member Business Meeting.

**Northwest Illinois Economic Development (NWILED) Annual Meeting** – Attendees were selected for the upcoming NWILED Annual Meeting. NWILED, a regional development entity, was formed to grow the economy and public/private partnerships in Jo Daviess, Carroll and Whiteside counties in NW Illinois.

Casper shared that an AI Usage Policy was adopted by JCE Co-op on September 24, 2024, to address the responsible use of AI at the co-op.
