# A new dawn for rural northwest Illinois

Rural northwest Illinois is not just gaining fiber—it's claiming a future. With strategic investments, regional leadership, and community-centered partnerships, JCE Co-op's fiber internet build-out is a powerful blueprint for bridging the digital divide—empowering small towns to thrive in a connected world.

Fiber build-out in northwest Illinois is accelerating, and its ripple effects will be profound. Most of the buildout will be completed by the end of 2026. The network will knit together farms, small towns, schools, clinics, emergency services, and businesses—and empower them with modern connectivity. When completed, the network will enhance safety, strengthen economic growth, modernize agriculture, support telehealth services and broaden lifelong opportunities.

This is more than just internet service. It's an investment in quality of life: families can work, learn, and stream; farms and businesses can modernize; entrepreneurs can innovate; and communities can thrive. What once felt like distant dreams—remote surgery, smart irrigation, global ecommerce—are now within reach because fiber is being laid in road and utility right-of-ways across the region.

In the coming years, northwest Illinois will stand as a model of what rural broadband can achieve. With the right mix of infrastructure investment, workforce training, and forward-thinking local leadership, the region is not just getting connected, it's preparing for a brighter, more resilient future.

#### **Transformational benefits**

#### 1. Economic development

Fiber broadband dramatically lifts local economies. In counties with high broadband utilization, fiber-connected regions show a remarkable 213% higher business growth rate, 10% higher self-employment growth, 18% higher per capita income, and 44% higher gross domestic product (GDP) growth. Available fiber makes rural communities more attractive to startups, remote workers, and innovation-oriented firms.

#### 2. Precision agriculture

Faster and more reliable connectivity enables precision agriculture—using real-time telemetry and smart tech to optimize planting, fertilization, and harvesting. A study from the Benton Institute for Broadband & Society across 15 Illinois ag counties estimates that enhanced broadband could boost corn and soybean revenues by over \$100 million annually—a big win for farm-based families.

#### 3. Education and telehealth

Fiber broadband ensures seamless access to remote learning and virtual health care. Robust connectivity bridges these gaps, supporting everything from telemedicine diagnostics to online student resources.

#### 4. Workforce development

Northwest Illinois is not just building fiber—it's building skills. Morrison Tech recently launched an apprenticeship program to train hundreds of fiber technicians over the next four years, linking the infrastructure build-out with local job growth and career readiness.



## Youth Tour opens minds and builds leaders

#### Local students represent JCE Co-op in D.C.

Every June, a select group of high school students from across Illinois leave their rural communities to spend a week taking in the historic sights and bustling energy of the nation's capital.

This year, 48 students sponsored by 25 Illinois electric and telephone cooperatives took part in the 2025 Youth Tour to visit Washington, D.C., held June 16 to 23, for an immersive weeklong experience designed to educate and inspire the next generation of cooperative and civic leaders.

JCE Co-op sponsored two students within its service territory. These students included Lex Abt and Hazel Harris. They joined more than 2,000 students representing 44 states for the annual event.

"This trip is so much more than sightseeing," said Taylor Smith, member and youth engagement coordinator at JCE Co-op. "It's about building relationships, learning leadership and showing that they have the power to shape their communities and futures."

Cemetery and, for the first time in many years, had the opportunity to tour the White House, where the students caught a glimpse of President Donald Trump. They also toured the U.S. Capitol, strolled the National Mall, stood at the steps of the Supreme Court and explored the Smithsonian museums.

Midweek, students took part in the National Rural Electric Cooperative Association's Youth Day, where they joined hundreds of other teens from across the country to hear from national leaders and learn how to use their voices back home.

From sobering visits to the Holocaust Memorial Museum and the 9/11 Pentagon Memorial to moments of laughter at the Museum of Illusions and teambuilding at Beat the Bomb, the Youth Tour experience was unforgettable.

"I'd say my favorite part of the trip was going to the United States Holocaust Memorial Museum," Abt said. "I liked really educating myself on everything that happened there, because I didn't know the in-depth history of it."

#### Learning by doing

Central to the Youth Tour experience is the formation of a mock student-run cooperative called Chip 'n' Pop Co-op. Students began their journey at the Association of Illinois Electric Cooperatives (AIEC headquartered in Springfield, where the students selected a co-op board. The board later interviewed and selected a co-op manager.

Throughout the week, the co-op handled snack sales, decision-making and budgeting — giving participants a hands-on look at how cooperatives operate. Both Abt and Harris served on the board of directors.

"Being on the board of directors taught me what a co-op is all about through first-hand experience," Harris said. "I've become so much more appreciative of everything that JCE Co-op is doing for me."

"Being part of a co-op helps students understand what makes a co-op different," said Smith. "It's all about working together and making decisions that serve everyone — not just one person or company."

#### A full week of history

Over the course of the week, students visited historic landmarks including Gettysburg, Arlington National

An important component to the trip — the students voted for one of their peers to represent Illinois on the Youth Leadership Council (YLC). Those interested in becoming Illinois' YLC representative filled out an application, and five were selected to give a speech in front of their peers.

Adams Telephone Co-Operative's Micah Anderson was selected as the 2025-2026 YLC representative for Illinois. He will represent the state at national and state meetings and events in the year ahead.

The week concluded with a farewell dinner and dance, and by the time students returned home on June 23, many said they felt changed by the experience.

"I would like to give the hugest thank you to my co-op for sending me to D.C.," Harris said. "They gave me the opportunity to look into the past of our country, and now I can't wait to help build the future."

## Billing cycle changes begin this month

Beginning this month, JCE Co-op is launching the first phase of changes to billing cycles for electric and natural gas members. As part of this update, our service territory is now divided into three billing cycles. While some accounts will remain on their current schedule, many will see new billing and due dates starting this month.


For over 70 years, the Farm Progress Show

## **Advancement in fiber internet buildout in Whiteside County**

Whiteside County is making major strides in expanding broadband access, as JCE Co-op advances its fiber optic construction across the northern parts of the county. The co-op recently received its final installment of funding from Whiteside County for fiber buildout in northern portions of the county.

Gary Camarano, economic development director for Whiteside County, presented a \$1 million check to Mike Casper, JCE Co-op president & CEO, and Jesse Shekleton, director & general manager of broadband at JCE Co-op. This check represents the final payment of the \$3 million the county committed to use as local matching funds for a Connect Illinois Round 3 grant from the state of Illinois. The county's match comes from ARPA funds received.

The co-op is using the \$69.9 million Connect Illinois funds to deploy high-speed fiber internet to areas of Whiteside, Carroll and Jo Daviess counties. Jo Daviess County contributed another \$50,000 in local funds.

Camarano noted that Whiteside County's commitment of local funds was one of the keys to obtaining the grant. JCE Co-op is using the Connect Illinois grant to construct 1,200 miles of underground fiber to areas in the three counties, enabling the

connection of more than 5,100 households, farms, and businesses.

This summer, construction has started on the fiber optic buildout project in northern rural areas of Whiteside County, with an estimated completion by year-end. This advancement marks a significant step forward in bridging the digital divide and fostering economic growth in the region.







**Safety Moment** – Director James reminded us that safety starts at home and provided safety tips. It's not just about being safe at work, it's about carrying those habits into your daily life. Some examples of being safe at home are:

- When mowing the lawn, always wear closed-toed shoes to protect your feet.
- When picking up debris in your yard, use gloves to avoid cuts, splinters, or harmful substances.
- When working with electricity, always use a tester first to ensure the power is off before handling wires.

#### **CEO| Financial Operating Report**

**CEO Report** – Mike Casper, President and CEO, shared with the board an

update on the special early retirement program.

Financial Operating Report - Chuck Woods, Chief Financial Officer noted that April revenue is approximately \$24.4 million. Total operations and maintenance expenses are approximately \$19.2 million, which is \$551,660 under the budget of \$19.8 million. Margins are approximately \$953,279 and are \$730,559 greater than budget of \$222,720, primarily due to non-operating activity over budget of \$446,274. By general consent, the board moved to file the financial operating report with the auditor.

#### Operations and Regulatory/ Legislative Update

Operations Update – Senior Vice President and Chief Operating Officer Kyle Buros provided an update on current projects. He noted that substation upgrades are progressing and emphasized that the organization remains focused on meeting its budget goals.

IT Technology Report – Vice President and Chief Technology Officer Dan Marcure provided an update on technology initiatives; detailing projects aimed at increasing fiber bandwidth capacity.

Member Services Update – Vice
President of Member Services Jennifer
Meyer discussed the implementation
of new software designed to improve
operational efficiency and enhance
internal communication and technical
processes. With the software upgrade a
new member-facing platform will provide
additional user-friendly applications
enhancing value to our members.
Meyer also provided an update on the
rollout of the new Advanced Metering
Infrastructure system and how we are
communicating with our members.
