- ❖ Equipment must be purchased, installed, and/or recycled in 2025.
- ❖ Installed equipment must be on Cooperative's lines.
- ❖ Incentives are in place from **January 1, 2025**, through **December 23, 2025**, or until funds are depleted.
- ❖ Please allow 3-5 weeks for your incentive to be processed once proper documentation has been received.
- ❖ JCE Co-op reserves the right to inspect and verify equipment and installation.
- ❖ All accounts are eligible for only **ONE** Incentive per appliance/unit within a 5-year period.
- ❖ **Submit ALL documentation listed below no later than 3 months after purchase/installation and no later than December 23, 2025,**
