SUBJECT: Irrigation Rate

AVAILABILITY

Available to all members for the sole purpose of pumping water for irrigation of land and are subject to the established rules and regulations of the cooperative.

CONDITIONS OF SERVICE

Three-phase, 60 hertz, at available secondary voltages.

RATE OPTIONS

Any new irrigation service will start on the rate for demand less than 75 kW. Once a service equals or exceeds the 75 kW demand threshold, the service will be billed using the rates associated with the equal or greater than 75 kW.

RATE PER MONTH

Demand Less than 75 kW

Facility Charge:	\$275.00	per month
Member Service Charge:	\$ 5.00	per month
Delivery Charge:	\$ 10.36	per kW

Purchased Energy Costs:

Energy Charge:	\$ 0.03963	per kWh
Generation Charge:	\$ 0.03220	per kWh
Transmission Charge:	\$ 0.02107	per kWh

DETERMINATION OF BILLING DEMAND

The billing demand shall be based on the highest fifteen (15) minute kW measurements during the current month.

MINIMUM CHARGE

The minimum monthly charge shall be the sum of the facility and member service charges.

OTHER CHARGES AND TAXES

This Schedule is subject to all other applicable charges and taxes including but not limited to: Power Cost Adjustment, Energy Assistance, Renewable Energy and all applicable state and local taxes.

TERMS OF PAYMENT
